

**CITY OF ORIENT IOWA
MINUTES OF THE CITY
PUBLIC HEARING
REGULAR COUNCIL MEETING
JUNE 13, 2022**

Mayor Swanson called the Public Hearing for Resolution 06-13-2022-1: A resolution to amend the budget for Fiscal Year ending June 30, 2022. Council members present: Travis Eggman, Deborah Harry, Joshua Madison, Gary Metzger, absent Justin Boswell.

Motion made by Council Member Madison 2nd by Council Member Harry to approve Resolution 06-13-2022-1 Roll Call Vote: All voting aye, motion carried. There were no comments heard from the public. Motion made by Madison 2nd by Eggman to adjourn the public hearing.

Mayor Matthew Swanson call the Regular Meeting of the Orient City Council to order. Council Members present: Travis Eggman, Deborah Harry, Joshua Madison, Gary Metzger, absent Justin Boswell.

Motion made by Eggman 2nd by Madison to approve the consent agenda, consisting of the Regular Minutes from May 9, 2022, Special Council Meeting May 16, 2022, and claims totaling \$60,703.63. All voting aye, motion carried.

Motion made by Metzger 2nd by Madison to amend the minutes from May 9, 2022, to say Dumpster Day will be for only one day, Saturday June 25 from 10am – 5pm. All voting aye, motion carried.

Motion made by Madison 2nd by Eggman to approve the cigarette license for The Hub Holding Company. All voting aye, motion carried.

Motion made by Metzger 2nd by Harry to adjust the employee's split pay percentages as follows: Maintenance Department: Road Use – Street 15%, Parks 5%, Water 15%, Electric 60%, Streets 5% General 5%. Clerk: Water 15%, Electric 37% and Clerk 48%. To start July 1, 2022, and to recheck in December 2022. All voting aye, motion carried.

Motion made by Madison 2nd by Eggman to increase the hourly wage for City Clerk from \$20.00 to \$21.60 an hour, effective July 1, 2022. All voting aye, motion carried.

Motion made by Madison 2nd by Eggman to increase the hourly wage for City Maintenance Superintendent from \$21.47 to \$23.18 an hour, effective July 1, 2022. 3 votes aye, 1 vote nay, motion carried.

Motion made by Eggman 2nd by Madison to purchase/fix the basketball hoop at the City Slab. All voting aye, motion carried.

Motion made by Madison 2nd by Harry to hire Wiley Ray at \$16.00 an hour part-time for basically mowing and small things that may come up. All voting aye, motion carried.

Motion made by Madison 2nd by Eggman to adjourn the meeting at 7:37 pm.
