**REGULAR MEETING**  
**FEBRUARY 10, 2020**

The regular meeting of the Orient City Council was called to order by Mayor Swanson on February 10, 2020 at 6:00 PM at Orient City Hall. The following council members answered roll call: Justin Boswell, Joshua Madison and Gary Metzger. Clarissa Pashek, was absent. Also present, Scott Tonderum, Greenfield Municipal Utilities, City Attorney, David Grapentine, Maintenance Superintendent, Jim Sitzman and City Clerk, Della Kramer.

Motion made by Boswell 2<sup>nd</sup> by Madison to approve the consent agenda which included the following: agenda for February 10, 2020, minutes of the January 16, 2020 Council Meeting, and approval of bills for \$30,529.65. All voting aye, motion carried.

Motion made by Metzger 2<sup>nd</sup> by Madison to pay employees ten percent (10%) of his/her accumulated sick leave upon retirement, if the employee qualifies for IPERS retirement benefits. All voting aye, motion carried.

Motion made by Metzger 2<sup>nd</sup> by Madison to approve Resolution 2020-02-10-01 **RESOLUTION TO AMEND THE EMPLOYEE MANUAL OF THE CITY OF ORIENT, IOWA FOR THE PURPOSE OF PAYING EMPLOYEES A PORTION OF THEIR ACCUMULATED SICK LEAVE AT RETIREMENT; AND ESTABLISHING AN EFFECTIVE DATE.** Roll call vote: Ayes: Boswell, Madison, Metzger. Nays: None. Absent: Pashek. Motion carried. Mayor Swanson declared **RESOLUTION 2020-02-10-01** duly adopted.

Motion made by Boswell 2<sup>nd</sup> by Boswell to approve Resolution 2020-02-10-02 **RESOLUTION TO SET PUBLIC HEARING DATE FOR FY 21 MAXIMUM PROPERTY TAX DOLLARS.** Roll call vote: Ayes: Boswell, Madison, Metzger. Nays: None. Absent: Pashek. Motion carried. Mayor Swanson declared **RESOLUTION 2020-02-10-02** duly adopted.

Motion made by Boswell 2<sup>nd</sup> by Metzger to appoint Scott Tonderum as the authorized representative for the City of Orient to the SIMECA Board. All voting aye, motion carried.

Motion made by Boswell 2<sup>nd</sup> by Madison to appoint Jim Sitzman to the Adair County Landfill Board to represent the City of Orient. All voting aye, motion carried.

Justin Boswell left the meeting at 6:08 PM.

Dean Brant from the Southwest Iowa Lions Club presented information on the Lions Club.

David Grapentine reviewed nuisance procedures.

Scott Tonderum reported to the Council how GMU is helping the City of Orient and resources available to continue to help the City.
